# Resolution for Adoption by the Ravenna Public Schools Board of Education

Resolved, that this resolution shall be the general appropriations of Ravenna Public Schools for the 2021/22 fiscal year as <u>amended</u>; a resolution to make appropriations; to provide for the expenditure of the appropriations; and to provide for the disposition of all food service revenue received by the Ravenna Public Schools.

Be it further resolved that the total revenues and unappropriated fund balance estimated to be available for appropriation in the food service fund of the school district for fiscal year 2021/22 is as follows:

This resolution shall take effect on December 13, 2021.
